## **STIPULATION EXTENDING TIME FOR FILING BRIEFS**

Appellant Center for Environmental Health (CEH) and the undersigned Stipulating Respondents, through their respective counsel, hereby stipulate to mutual 60-day extensions of time for the filing of the remaining appellate briefs in this matter, pursuant to California Rules of Court, rule 8.212(b)(1). The time for filing these briefs shall be as follows:

1. Stipulating Respondents shall have an extension of 60 days to file Respondents' Brief(s) so that responding briefs shall be due March 22, 2022.

2. Appellant CEH shall then have an extension of 60 days to file its Appellant's Reply Brief so that the brief shall be due 80 days after the filing of the last of Respondents' Brief(s).

This stipulation shall be without prejudice to any party seeking further extensions of time from the court, if necessary. In the event the time for filing of an opposing party's brief is extended by order of the court or if the brief is not filed by the date it is due, it is understood the extensions of time agreed to in this stipulation shall run from the date the brief is actually filed.


